PROGRAM HIGHLIGHTS

This year, New Horizons assisted nearly 1800 consumers and their families. In New Horizons' 64-year history, this is a record number of people benefiting from its programs and services.

EMPLOYMENT SERVICES

Best in Los Angeles County for Individual Placement

Employment is a key component of giving individuals with disabilities independence, freedom of choice, and community integration. New Horizons is proud to provide more jobs in the community for people with intellectual and developmental disabilities, as well as those with rehabilitation challenges in Los Angeles County.

Pathways

As a doorway to Supported Employment, this program assists individuals in developing job experience by working at businesses on a time-limited basis. The participants are paid by New Horizons and thus provide a volunteer labor force. Kohl's, Providence Tarzana Medical Center, JONS International Marketplace, 99 Cents Only Stores, Vons, Marshalls, Office of Congressman Tony Cardenas and CSUN are some of our partners where the Pathways program is implemented.

Job Club

Whereas the Pathways program uses on-the-job training, the Job Club teaches skills in a classroom setting. It is offered at New Horizons, preparing our clients to find meaningful work in the community.

Direct Job Placement (Special Rehabilitation Clients)

In FY 2017, 105 people have been referred to New Horizons and 72 have been placed with both new and existing employers in the community. These include individuals who do not have developmental disabilities, but may have other barriers to employment.

Still Earning the Business

The New Horizons team successfully navigated the transition of nearly 60 clients out of our on-site **Workshop** and into our Community Day Program and other employment options. For the 120 clients who remained in the Work Activity program, they continued to learn valuable work skills while earning a paycheck, in a variety of jobs including light manufacturing and fulfillment services.



The Workshop currently serves 120 trainees who achieved 99% of their goals this year.

Sam's Café continues to boast a full professional kitchen, facilities for up to 250 guests, Wi-Fi, ample parking, and affordable rates. During FY 2017, it remained the perfect location for client dances and parties, baby showers, children's parties, wedding receptions, quinceañeras, holiday parties, community service clubs, and business meetings held by such organizations as the Valley Industry & Commerce Association (VICA) and the North Los Angeles County Regional Center. Sam's Café is also the home of New Horizons' famous cookies. which were featured at every New Horizons event, sold at Vons stores in Mission Hills and Pavilions in Burbank, given to local community legislatures, shipped nationwide as corporate gifts, and became a delicious part of the LA Cookie Con event in February 2017, to rave reviews.

In fiscal year 2017, **Community Living** provided assistance with menu planning, budgeting, money management and a host of other training opportunities to participants choosing to live on their own. These individuals were encouraged to participate in a variety of community-based recreational opportunities at such places as concerts, fairs, and shopping in a variety of settings.

In addition, rigorous surveys and inspections from the Los Angeles County Departments of Health and of Social Services yielded perfect compliance for five of the homes, at New Horizons I, 56A and B; Chase; Odessa; and the Balboa nursing home.

TRAVEL TRAINING PROGRAM (GLM)

Creating a Community on the Move

This year a continuation of funding from the Los Angeles County Metropolitan Transportation Authority was secured to extend the GLM program to seniors and individuals with disabilities for another two years. This follows the success of the initial three-year cycle. As a testament to New Horizons' strong belief in community services, this program was launched to train individuals to use public transportation so they could better access employment, recreation and other resources. Some of the training sites specifically geared to seniors include Fickett Towers, ONEgeneration Senior Enrichment Center, Robert M. Wilkinson Multipurpose Center, Owensmouth Gardens, Heritage Senior Living, Vintage Crossing Senior Apartments, Montecito Terraces Senior Apartments, and Sherman Oaks East Valley Adult Center.


COMMUNITY DAY SERVICES

Transitioning that Benefits our Clients and the Community

This year, the new Community Day Services was launched. The purpose of this half-day program is to facilitate learning vocational skills in the community through volunteer opportunities. There have been many sites developed for the Community Day Service, among them: North Valley Caring Services, Hope of the Valley Rescue Mission, San Fernando Valley Rescue Mission / Super Thrift Store, MEND - Meeting Each Need with Dignity, Heavenly Pet Resort, Best Friends Animal Society, Friends of the Family, Dept. of Recreation and Parks in North Hollywood and Panorama City, and Union Rescue Mission / Hope Gardens Family Center. The other half of the day, our participants receive classroom instruction in functional skills attainment for employment and the social behavior expected in community based settings.

LEARNING

With services open to a broad spectrum of clients, including those with intellectual and developmental disabilities, 640 individuals were served by GLM in FY 2017:



While helping 100s, our clients contributed approximately 7,700 volunteer hours to the community.

ACHIEVEMENT CENTER

Where Learning Never Stops

Having focused on classroom space and building a staff of highly trained professionals, in FY 2017 in our **Achievement Center** it was all about the classes! Participants enjoyed a day program that included safety training, cooking lessons, arts and crafts, Metro training, fitness instruction courtesy of a grant from Kaiser Permanente, and drum circle, along with self-advocacy and much more, like the City of Los Angeles Department of Cultural Affairs Art Class and Show, where participants from classroom 5 sold their art to excited buyers.



TECHNOLOGY MEDIA ARTS (TMA)

Falling under the Achievement Center program, TMA offers exciting work and educational opportunities to clients who show an interest and talent for technology and media arts in preparation for careers in web design, graphic arts, and animation. This year, TMA was honored to be selected to participate in the 2nd Annual LA Council member Mitchell Englander's (CD-12) "Making Movies that Matter" (MMTM) and Short Film Festival. With twelve weeks of classroom study funded by the Council member, New Horizons received practical training provided by a CalArts Artist in Residence with the purpose of helping the participants produce a video about issues that interest them. After submitting their completed videos to the film festival, New Horizons clients were awarded, before family and friends, a special trophy for community spirit in honor of their efforts at California State University, Northridge's Valley Performing Arts Center on May 24, 2017.

MONARCH MOBILE DAY PROGRAM (MMDP)

Serving Clients in the Community

As a program that takes New Horizons' Achievement Center-type day services on the road, MMDP was one of New Horizons' first programs to offer its services entirely in the community when it began specializing in assisting a more fragile clientele outside of the organization's North Hills campus.

The staff brings program services to the client: in their family home; skilled nursing facilities; community care facilities; continuous nursing; or specialized residential services (CPP). The MMDP program is expected to be in even more demand as facility-based programs become less of an option in favor of inclusive environments. It is a program that is quickly expanding in regard to staff and participants based upon demand and its many Regional Center referrals.

In its third year of operation, the program benefitted 40 individuals who due to intellectual disability, medical conditions or physical disabilities are unable to attend a campus-based day program.


